PRODUCT DESCRIPTION: Our siding profiles undergo multiple testing as per Canadian and American standards with intention to provide a performant product from both an aesthetic and structural standpoint. Polymac panels are manufactured using 22/24 ga grade 33 ksi galvanized prepainted steel as per ASTM A 653/A 653 M and are rollformed to ensure consistent dimension and quality; they also have a laminated foam backer for added rigidity but can also be manufactured without the foam backer for use on non-combustible constructions that would require so. Profiles are tested for fire resistance, deflection under wind load, maximum sustained pressure and have various accreditations. For a complete list of testing per profile, we invite you to review the product datasheets available on our website. Paint colors covered by this HPD are listed in Section 5 - General Notes.

This HPD presents the individual alloying elements that, when combined, make up the grade 33 ksi steel metal alloy used in the Polymac sidings. It should be noted that a metal alloy is a material made by combining metals and/or other elements (alloying elements). The alloying process modifies the properties of the material, usually providing increased strength, malleability, or resistance to corrosion. Steel itself (CAS RN 12597-69-2) does not have a Green Screen Score nor hazards (refer to Pharos). This HPD includes multiple Polymac panel size and steel thickness; hence, weight intervals are used to cover the variation between this line of products. Also, different paint types are available and are shown as alternative materials. Not all substances are identified as some are considered confidential and thus shown as undisclosed. Finally, an "Exception for proprietary ingredient" has been used for the Hot Melt Adhesive Material for which the composition by substances CAS RN has not been identified. The Hot Melt Adhesive Material represents less than 5 wt.% of the product and is a homogenous material.
